Dear Respected Members,

It is solely through the grace of the Almighty, your prayers and support that MCND has been working for 18 years in the North West of Dublin. From our humble beginning as a small congregation in 2003 praying only Taraweeh during Ramadan and organising Eid prayers, we have evolved into an organisation that is running a fully functioning mosque, sponsoring Dawah and charities that provide aid to people who are in need and empower people through education. It has been a long journey with many hurdles but with your phenomenal support and prayers, we have managed to overcome them.

As a donor, you deserve to know where all your hard-earned money is being spent and we can assure you it is going towards worthy causes. In this report, the board of directors present their annual activities together with the Financial Statement of Muslim Community of North Dublin CLG.

The Directors affirm that the Annual Report and money related proclamations of MCND are in accordance with the CRO, the Charity Regulator and the Revenue's rules and standards for the Republic of Ireland.

The services offered at MCND continue to grow in size as well as variety. We continue to review the effectiveness of our services. A fundraising strategy has been put in place and implemented. We continue to review the fundraising strategy as well as our strategy as an organisation. We have set up a separate bank account for the Mosque Project. We hope to continue exploring other avenues for funding. We are working on developing and improving our website www.mcnd.ie to enable the community to access the various activities and events during the year.

MCND is now a registered body with the National Vetting Bureau. Also, MCN is authorised charity for the Revenue Donation Scheme.

The main highlight of the year was the decision taken by the board to purchase the premises which is currently used as Mussala. This building will be used as the main centre for MCND activities till we build our dream purpose built Islamic Centre. We would like to thank our members for supporting this decision and the incredible generosity they showed. More than €200,000 were collected within 4 weeks of the date of the SGM. No doubt it is the most important decision taken and the biggest transaction in the history of MCND.

It was a year of growth and development in MCND. We embarked on a strategic plan for our activities and especially for our mosque project. During the year very slow progress has happened in securing a land for our permanent Islamic centre. After a lot of uncertainty regarding Damastown Avenue land, we recently got promising news from Fingal County Council.

It has not been a year without challenges for the board and for the community. The COVID-19 pandemic had a serious impact on our activities. We ask Allah SWT to lift this pandemic soon and to protect all of us.

We would like to take this opportunity to thank you all for your donations and support as well as the brothers and sisters who have contributed with their time and effort to support MCND over the last year. We believe that working together as a Muslim community, there is no limit to what we can achieve. Unity is our strength.



MISSION AND OBJECTIVES

Our mission is to gain the pleasure of Allah by serving the best interests of Islam and Muslims in the North-West of Dublin particularly, and in Ireland more broadly, by helping Muslims practise their faith according to the Qur'an and Sunnah.

Our aims are to:

- 1- Promote education by providing classes in Islamic studies and Qur'an as well as other social and cultural activities of Muslim community.
- 2- Co-operate with other similar charity bodies on beneficial causes.
- 3- Provide religious services such as the five daily prayers, Friday prayer and Eid prayers.
- 4- Support and run youth activities throughout the year
- 5- Provide a prayer space that is accommodating to all Muslim, reflecting the community's diversity in gender, national origins, culture, age, socio-economic and educational backgrounds.

Our strategy to achieve some of our objectives can be summarised in the following points:

- A. Continue to hold regular Islamic programs and projects in the mosque as well as upload beneficial talks and lectures on our new website- www.mcnd.ie
- B. Organise a variety of activities including, but not limited to social, cultural, religious, and educational activities.
- C. Strengthen brotherly bonds and relations among Muslims.
- D. Offer Muslims in the North-West of Dublin, and local areas, membership and active participation in MCND's activities.

MEMBERSHIP

The charity is open to the public for all activities that aim to fulfil the objectives of MCND. Full membership of the MCND is free and shall be open to:

- Muslim individuals of 18 years and over, who are residing legally in Ireland and live in north of Dublin.
- Juniors under the age of 18, who are interested in participating in the work of the MCND subject to consent of their parents, are not entitled to vote at general meetings.

MEETINGS, SGMs AND SUBCOMMITTEES

The board of directors had 10 meetings since being elected in October 2020. Minutes of the meetings are kept and maintained by the Secretary and ready for inspection by members. To inspect the minutes members must make a formal request by contacting the Secretary.

One SGM was held on 13th June 2021 to discuss and vote upon resolution proposing the purchasing of Unit 6 Coolmine Industrial Estate, Dublin 15 by the MCND to be used for the Community activities. The resolution passed by majority of 94% which surplus the required 75% for any Special Resolution.

Two subcommittees were formed during the year by the board. The first subcommittee is to look at the Cash Handling procedure and consisted of Amadou Diop, Brian Doyle and Kamal Ghanem.

The second subcommittee is to look and the Memorandum and Article of the Association and to advise the board of any amendment is needed. This subcommittee consisted of Fazal Memon, Brian Doyle and Samir Brihi

CURRENT ACTIVITIES

- 5 daily prayers (Coolmine Mussala, Coolmine Industrial Estate, Dublin 15).
- Weekly Friday Sermon (Hartstown Community Centre & Coolmine mussala)
- Education and Training:
 - Qur'an memorisation 4 times per week
 - o Arabic Classes Bi-weekly
 - o Religious Education Bi-weekly
 - o Womens Qur'an and Islamic studies classes- 5 days a week
- Youth Club
- Festival Celebrations (only one Eid took place during the year due to Covid restrictions)
- Ramadan activities: Ramadan was different this year due to COVID-19. We had to change the way we run some of the activities and had to cancel others.
 - o Collect your Iftar
 - Iftar for frontline workers and people who are in cocooning
 - o Collection and distribution of Zakat-al fitr
 - o Quran Competition.
 - o Virtual Friday collection for expenses and Mosque Project.
 - Fundraising for the Mosque project.
 We run a very successful "Collect your Iftar" last Ramadan. Two local restaurants were involved Falafel and Darbar. Thanks to all involved.

Kickboxing Club

Since December 2018, MCND has been running a Martial Arts activity (Kickboxing techniques) opened to children and adults and taking place every Sunday morning. The activity is led by brother Aziz who is a professional and fully qualified trainer. The goal is to encourage everyone of our community to exercise and stay fit and healthy as we Islamically ordered. The number of participants has rapidly grown to roughly 25 kids and 10 adults coming regularly to the training session. A small amount of €10-15 per person is required just to cover the rent costs.

Unfortunately, we had to stop this activity due to COVID-19.

The ICT team did a great job by developing our website and launching MCND prayer times App. Sincere thanks to Gamal Dawood and Ahmed Nashaat.

FUTURE PLANS

Vision for the future is:

- To continue collecting funds that will contribute towards the purchase of a permanent premise for all our activities that accommodates all its members including women, children and those with special needs. There have been developments and progress in relation to the Damastown Avenue land. We will soon know if the project will get the green light and the price of the land. We will inform you as soon as more information unfolded. We need to work very hard collectively to ensure that we have enough funds in case we are offered the land.
- To continue to expand our current educational, spiritual and sporting activities for all members of the community.
- To promote interreligious dialogue.
- To establish a sports club.
- To develop policies and procedures to make MCND a better and more functioning organisation.

FUNDING

The charity is financially supported by donations after the Friday prayer collections, from regular community members and others in Ireland. In relation to our Mosque Project, avenues for funding outside the immediate community need to be explored. A realistic plan for local fundraising is to identify 200-250 people who can contribute approximately $\[\in \] 2000$ per year for the next three to five years, as well as to identify those who can donate more than this. We are working on this plan now. The total amount collected for the Mosque Project is $\[\in \] 442,548.49$ and for the expenses is $\[\in \] 41,337.80$ (As of Monday 04/10/2021).

Other approaches have been considered and some have already been implemented such as the Ramadan Campaign and GoFundMe and Card Sum-Up machines. We also have collections boxes at various mosques and shops. We are also considering international donations to fund our project.
